SGM & ELECTION NOTIFICATION

Dear Sir,

This is to inform you that as per the decision of Annual General Meeting held on 22.04.2018 at Talkatora Indoor Stadium, New Delhi, it was unanimously decided to hold the Special General Meeting and the elections of the Governing Body/office bearers of the Karate Association of India (KAI) for the next term 2018-22 in the month of September, 2018 and the same has been scheduled to be held on **23rd September 2018 at 11.00 AM at Hotel Bharat Continental, New Rajinder Nagar, New Delhi**. The notice for SGM along with agenda items is being issued separately.

The Election are to be held as per Constitution of the KAI and the provision of National Sports Development Code of India (NSDCI) including the Model Election guidelines circulated by Ministry of Youth Affairs and Sports, Government of India, Wherever there is a conflict between the constitution of KAI and provision of Model Election Guidelines, the model election guidelines will prevail.

The Electoral College of the KAI is at Annexure-I the Model Election Guidelines of the Government are at Annexure-II.

A copy of Government of India vide letter No. 52-11/2011-SP-I dated 3rd April, 2012 and No. 9-38/2016-SP-I dated 14.02.2017 (Annexure-III) is enclosed for perusal. Accordingly the employees of Union/ State/ UT/ Governments and PSUs/ autonomous bodies under them who are willing to contest the elections are required to obtain the permission NOC of the concerned employer for holding an elective post in the Federation, such permission duly attested at the time of filing the nomination, is to be submitted along with the nomination form to Returning Officer. The original copy of permission/ NOC may be called upon for verification whenever necessary.
