These Rules are posted on our website also.</p> <p>Date of Birth certificates registered within one year of the birth of the child alone will be recognized and allowed to participate in age group championships by the KAI and all affiliated members of KAI.</p> <p>To help those children who have not registered their birth within one year of their birth, the NSF on every year before March / April announces two days</p> <p>For medical test to determine their age. The above Rules have been followed very meticulously every year.</p> <p>Further, players shall present themselves for Medical Test to determine their age at any time when called upon to do so by Karate Association of India (KAI) on of its affiliates. The KAI will have the powers to arrange for Medical test to determine the age of any player at any time if there is a suspicion.</p>

We have educated and cautioned the players and coaches against doping every time before the championship. The World Karate Federation (WKF) complies to WADA/NADA code. Doping test is conducted during big championships only. So far we have not had any cases found positive.
