
Consequent to nomination of the undersigned as Returning Officer to conduct the election of Karate India Organisation (KIO) on **08.05.2024** at Hotel Elite, Saharanpur Road, Patel Nagar, Dehradun, Uttarakhand at 11.00 AM to elect the Governing Body Members of KIO for the term of 4 years from 2024 to 2028 and in exercise of the powers vested in me as Returning Officer, I hereby notify the following:

I. Details of Posts to be Elected

Joint Secretaries	Three
Executive Committee Members	Three

II. MANNER OF ELECTION:

- The Elections will be held as per the provisions of the Article of Association of KIO. The election shall be held through secret ballot only. No proxy voting shall be permitted.
- Every Unit shall be entitled to nominate not more than two names for the Voter's list. Consequently, each Unit will have not more than two votes.
- Each voter shall carry document, having his photo, to prove his identity at the time of the nomination and election. The document shall have been issued by any authority of the Central or State Government.
- Duly filled-in Nomination forms in Form No:2 to be physically delivered in person to the Returning Officer by the contestant and proposer/seconded, as detailed under the following Schedule.
- Each candidate shall be entitled to be nominated by not more than 2 nomination papers.
- No person shall be eligible to nominate more than the number of posts for the same position, either as Proposer or Seconder.
- No person shall be permitted to withdraw his/her name as proposer/seconded, once the nomination paper subscribed him/her has been delivered to the Returning Officer.
- The employees of Central/State government and their undertakings, if any, will be required to obtain No Objection Certificate (NOC) from their employers and submit the same along with the nomination form, if they wish to contest the elections.
- The activities of the election process will be displayed at the notice board of the RO's office as well as on the official website of KIO i.e. www.karateindia.org
